Policies

- **Sessions:** Payments are due at time of service. Methods of payment accepted are: Cash, Check, Credit/Debit Cards and PayPal. A 24-hour cancellation notice is required for sessions. If it is necessary for you to cancel your appointment within the 24-hour window or the appointment is missed, the full session fee will apply.
- **Workshops:** Payment for Full Day Individual Workshop is due at booking. Cancellations one week prior to appointment will be refunded (less 15%).
- If you are unable to use a pre-purchased session for any reason, you may place the session on a three-month hold. Session credits will not be carried out longer than three months. You may also gift the session within this three-month period if desired.

Confidentiality

The conversations within our sessions are confidential and will be protected as such. Information will only be shared outside our sessions with your written consent or by order of a court judge. However, I would be obligated by law to break our confidentiality agreement without your permission if:

- It is assessed during your participation in coaching sessions that abuse or neglect of children or elders is occurring.
- In my presence you threatened to harm or kill yourself or another individual and I am convinced that you will act on this intention.
